

**BLS EVENT STAND-BY AGREEMENT**

**WITNESSETH:**

In consideration of the mutual covenants, promises and agreements contained herein, and intending to be bound hereby, the parties agree as follows:

1. Service Recipient agrees to pay West End a fee of (check applicable):

for the stand-by services under this contract.

2. West End will provide one BLS Squad (“Squad”) consisting of:  
Ambulance/emergency service vehicle

3. Stand-by services shall mean the sole function of the Squad will be to be on stand-by at the Event (as Event is hereinafter defined). In the event of notification by Service Recipient of an injury or medical emergency, the Squad will provide emergency Basic Life Support (“BLS”) services and transportation services as if they were called to respond to the injury or medical emergency.

The Squad is not a replacement or substitute for athletic trainer, nurse or physician.

5. Any cancellation by Service Recipient requires a minimum of 72 hours notice. Service Recipient agrees to pay West End a \$200.00 cancellation fee for failure to provide the minimum 72 hour cancellation.

6. The Squad is not responsible and assumes no duty for a catastrophic medical emergency, which shall mean a medical emergency that is beyond the ability of one ALS squad to address.

7. The Squad and equipment is specifically not for static display, viewing or touring by event participants or spectators.

8. West End and/or the Squad will not provide stand-by services and is not responsible for any emergency that may occur when the Squad is not present at the Event while transporting a person(s) to a medical facility or returning to the Event.

9. In the event West End is required to transport any person(s) to a medical facility from the event, West End will bill such person(s) the usual and customary charges for such services. However, the Service Recipient shall bear the responsibility for any unpaid bills for services rendered by West End.

10. Service Recipient represents that attendance, including participants and spectators, at the Event is less than 5,000 and is not termed a special event under applicable laws, rules or regulations. All necessary special event EMS planning requirements are the sole responsibility of the Service Recipient.

IN WITNESS WHEREOF, each party hereto, being authorized to do so and intending to be legally bound hereby, has duly executed and entered into this Agreement on the date first set forth above.
